Formation of Anti-ragging committee:-

The consensus was arrived on following points-

- a. Discussion on the ways to prevent ragging in the institution, whenever it is opening.
- b. A student committee will be formed to keep an eye on the students, on opening of college.
- c. The following faculty members are in the anti-ragging committee and will look in to the specific instances of ragging and complaints of ragging and suggest appropriate action punishment.
- d. The ragging is totally prohibited in Campus and anyone found guilty of ragging and/or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with UGC Regulations as well as under the provisions of any penal law for the time being in force” are being got printed and will be pasted by the office at all important places in the College Campus.




- e. College will arrange to display Flex Boards carrying anti-ragging message along with important Telephone Nos. at various prominent places on the University Campus.
- f. Committee members will address new students and senior students in separate sessions in the college auditorium making them aware of the anti-ragging law and its punishments.
- g. Surprise squad visits will take place at various places in campus and hostels etc, upon opening.
- h. Meeting of anti-ragging committee with the students of anti-ragging will be held weekly, once college will reopen.
